

# DONOR RELATIONS AND FUNDRAISING POLICY

**Kabalega Foundation** is committed to conducting its fundraising activities in a professional, ethical, and transparent manner. This **Donor Relations and Fundraising Policy** sets out the Foundation's approach to fundraising and its relationships with donors, ensuring that funds are raised and used in a way that aligns with the Foundation's mission and values.

#### 1. Purpose

The purpose of this policy is to:

- Ensure transparency and integrity in all fundraising activities.
- Establish clear guidelines for donor relations and the management of donor funds.
- Promote ethical conduct and accountability in fundraising.
- Strengthen relationships with donors and ensure they are informed and valued.
- Ensure that funds raised are used responsibly and for their intended purposes.

## 2. Scope

This policy applies to all fundraising activities conducted by Kabalega Foundation, including:

- **Individual Donors**: Individuals who contribute to the Foundation through one-time or recurring donations.
- **Corporate Donors**: Companies and businesses that provide financial support or inkind donations.
- **Foundations and Trusts**: Private and public grant-making organizations that provide funding to the Foundation for specific projects or programs.
- **Government and Multilateral Agencies**: Public sector entities that provide financial or resource support to the Foundation's initiatives.
- **Fundraising Events**: Public or private events organized to raise funds for the Foundation's activities.

### 3. Guiding Principles

Kabalega Foundation follows these guiding principles in all donor relations and fundraising activities:

- **Transparency**: All fundraising activities will be conducted transparently, with clear communication about how funds will be used and how donors' contributions are managed.
- Accountability: The Foundation will be accountable to its donors for the use of funds, providing regular reports on how donations are spent and the impact of the work being supported.

- **Non-Discrimination**: The Foundation will not engage in fundraising or accept donations that come from sources that engage in discriminatory practices or that could damage the Foundation's reputation.

#### 4. Donor Engagement and Stewardship

- **Regular Updates**: Donors will receive regular updates on the impact of their donations, including reports on projects funded and the progress of programs.
- Personalized Communication: The Foundation will ensure that donors are informed about the specific outcomes of their contributions and the ongoing work of the Foundation.
- **Donor Privacy**: Kabalega Foundation respects the privacy of its donors and will not share donor information without consent, except where required by law.
- Appreciation: The Foundation will regularly express gratitude to its donors, recognizing their support and ensuring that they feel valued for their contribution to the Foundation's mission.

#### 5. Fundraising Strategies and Methods

Kabalega Foundation will use a variety of ethical fundraising strategies to raise the necessary resources to achieve its mission. These strategies may include:

#### 9. Conflicts of Interest in Fundraising

To avoid conflicts of interest, Kabalega Foundation will:

- Ensure that staff, volunteers, and Board members involved in fundraising do not personally benefit from donations or fundraising activities.
- Establish mechanisms to disclose and manage potential conflicts of interest related to fundraising efforts.

• Maintain strict separation between fundraising and operational decision-making to ensure that donations are used for their intended purposes.
